# **Proceedings**

LHS FFA Ag Issues team presented on issues of ground water nitrates connected to dairy operations.

Verne called meeting to order at 2:19

#### 1. Consent Agenda

- a. The agenda was reviewed
- b. Minutes from the January meeting was reviewed.
- c. The financial report was reviewed.
- d. Voucher B.Gen.0225 in the amount of \$10,746.84 was reviewed.
- e. <u>Mike moved to approve the consent agenda. Greg seconded. Motion carried unanimously.</u>

# 2. FEMA Projects

- a. Gavin provided a FEMA update. Still awaiting ITB approval for Farm Field debris project. Parklyn Drainpipe project is ready to do final closeout.
- b. There is work being done with commerce on relief funding from HUD.

#### 3. CLASS

- a. Ethan provided a CLASS update.
  - i. Meeting on February 5 had attendees from NRCS, City of Lynden, Whatcom County, NSEA, Nooksack tribes and local farmers.
  - ii. Still need to work out permitting requirements, sizing of culverts to handle overflow from other basins and funding sources, especially for Rathborne Rd.
- b. There is a desire to have Rathborne Rd culvert plugged as soon as possible. Once the H&H study is finalized, CLASS team can pursue early action options there.

# 4. Ag Water Board / Water Supply

- a. Gavin shared a legislative update provided via email by Bill.
  - i. SB 5212, which would allow pre-code water users without a statement of claim to file in the adjudication, is on the Senate's consent calendar, and will likely see floor action within the next few weeks.
  - ii. Bill met with the new water resources staff from the Governor's office and expresses the need for more collaboration to lead to a settlement process.
- The AWB meeting with federal lobbyists was discussed.
- c. A member shared a Food insecurity group is putting pressure on ecology to provide funding for increased irrigation water supply, including in Western Washington.

# 5. Drainage / Habitat / Flood

- a. Ditch maintenance was discussed. County roads department has indicated that they do not believe that it is their responsibility to maintain roadside ditches.
- b. A member mentioned Ebeneezer school keeps flooding. This has not happened prior to this year. Discussion followed on local drainage in that area and potential causes.
- a. Frank gave an update on buffers. SCC buffer program is seeing some delays.

# 6. Water Quality

a. Trevor provided a water quality update through email. Numbers look good. There were some high marine counts in November and December.
